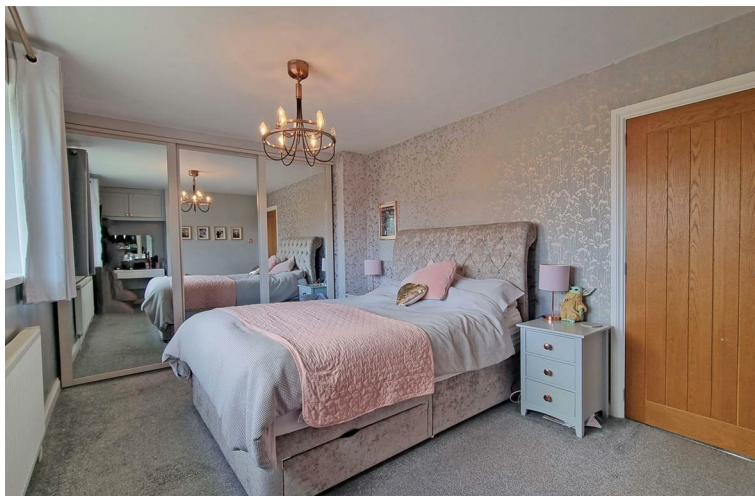
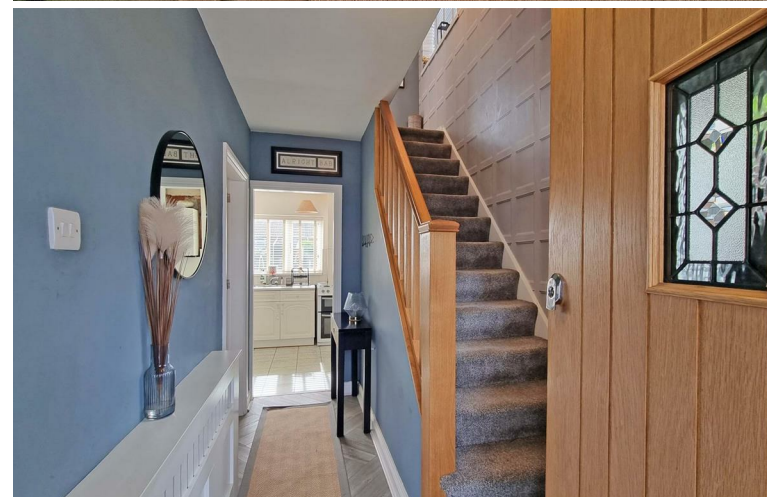
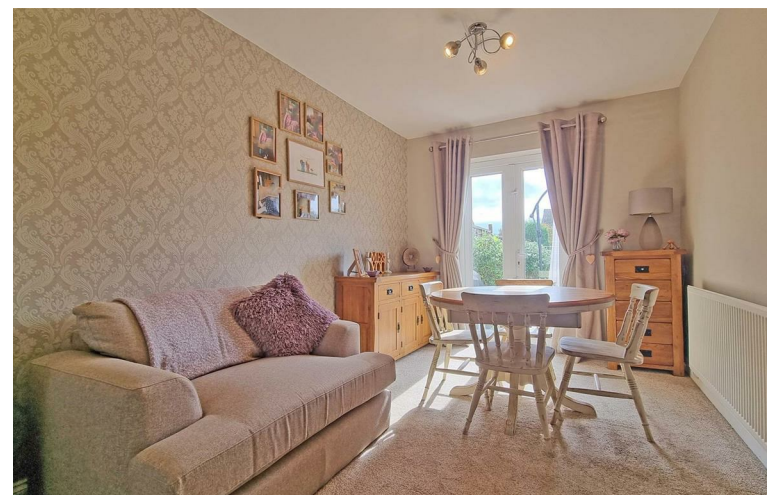
There is the benefit of local shops on May Lane, Drakes Cross parade and Alcester Road in Hollywood. The property is just a few minutes drive or by bus to Shirley along Trueman's Heath Lane and one can continue back through Hollywood to Sainsbury's at the Maypole island, which also provides access to Birmingham city centre and the southern Birmingham suburbs, along with the Hollywood by-pass which links to the M42, forming the hub of the Midlands motorway network.

There are railway stations close by in Wythall and Whitlocks End offering commuter services between Birmingham and Stratford upon Avon, and local bus services provide access to the City of Birmingham, Redditch and the surrounding suburbs.

Set back from the road via a tarmac front driveway flanked by lawn a UPVC door opens into the porch with oak door into the hallway with stairs to the first floor accommodation and doors to the lounge diner and kitchen with further access into a side store room with access to the rear garden.

On the first floor there are two good sized bedrooms and a refitted bathroom.

The large rear garden has a patio area leading to extensive lawn with timber shed, fencing to boundaries and gated side access.

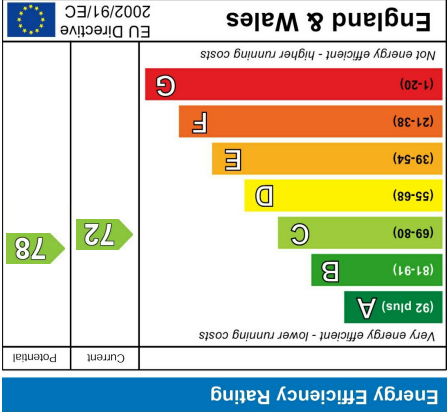
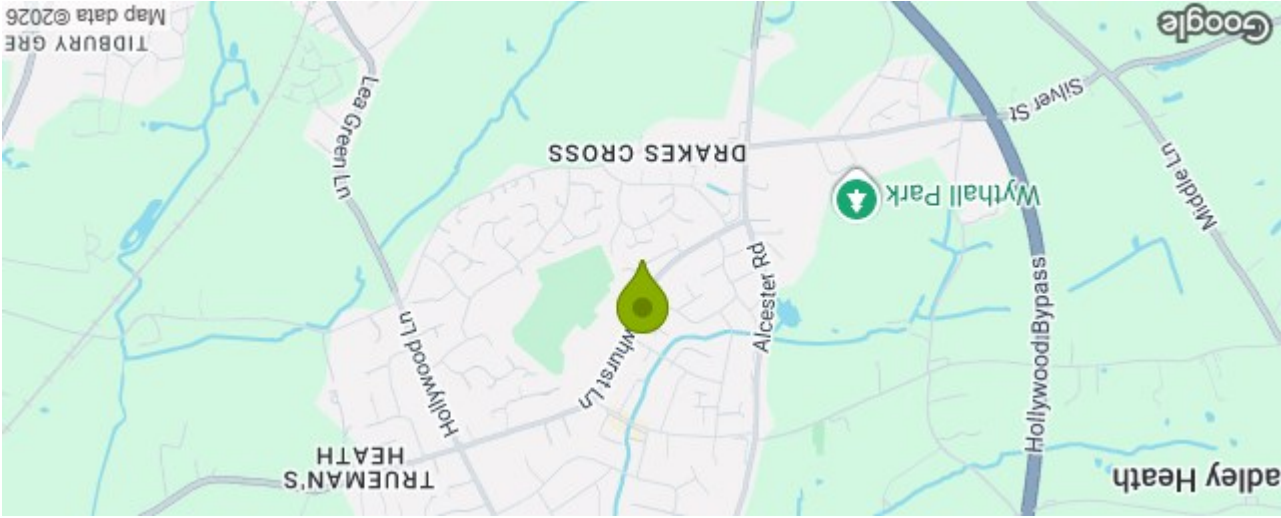
