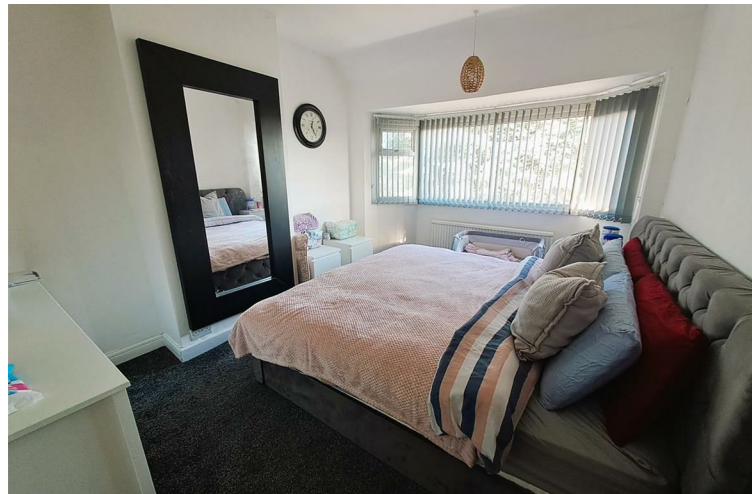
SOUGHT AFTER ROAD!
