Close to well regarded schools including King Edward Camp Hill Grammar school with the benefit of local shops at the junction on both Kings Road and the High Street itself, the property benefits from being within walking distance of Kings Heath High street where there is a variety of eclectic shops, restaurants and hostleries all along the Alcester Road. There is access also via the main A435 to junction 3 of the M42 motorway (via the Hollywood bypass) forming part of the midlands motorway network with access to the M5, M6, and M40.

There are railway stations at Yardley Wood, Kings Norton and soon to be Kings Heath offering commuter services between Birmingham and Stratford upon Avon and local bus services provide access to the City of Birmingham and the surrounding suburbs.

Set back from the road via a lawned front garden with driveway, a UPVC double glazed front door opens into the porch with further door into the hallway with stairs to the first floor accommodation and doors into the lounge and modern kitchen diner.

On the first floor there are three bedrooms and a modern bathroom.

The rear garden has a patio area with large lawn and fencing and walls to boundaries.

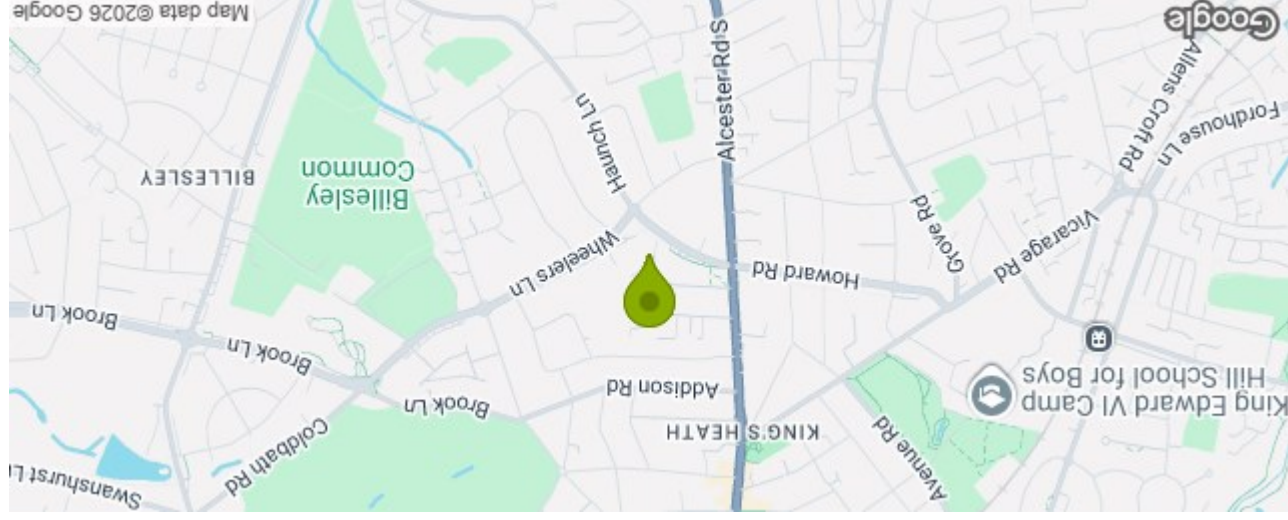
